Around 60 companies, in a variety of sectors and stages, have been given the opportunity to learn about what attracts investors, and to refine their own pitching skills. The companies in our exhibition area have

each been through our investor-driven feedback and selection processes.

From these businesses, the investors' top eight companies have each been asked to present at today's Pitch Up heats. Over the course of the day our judging panel of investors will review these top eight pitches and score them. You can watch these competitions in the Ashtead Suite (1st floor of Eastside Rooms).

In between the heats and the final we have invited some past participants to come and join a panel session; *Where are they now? Take inspiration from those who have done it before.* This panel session is in the Ashtead Suite at 12:10.

This afternoon, at 15:00 in the main room (Belmont 1-2), as well as celebrating all of our finalists, we will be announcing the final three.

But this leaves the question... who is the best? The final three will immediately pitch once more and this time you, the audience, will decide the winner of the *Pitch Up 2024 Best Pitch Award,* £2,000 cash prize and access to Minerva Business Angels. The runner up will get £1,000 cash prize. To help you make your decision, we'll have another fantastic panel of investment specialists on stage ready to ask some searching questions.

Mark Platt Co-founder, Figura Analytics (2021 Pitch Up winner)

Until 2022 Mark was a Reader of Nanotechnology within the chemistry department of Loughborough University. Having joined the dept in April 2012 as a probationary lecturer, developing the area of aptamer sensors and resistive pulse sensors. He grew the research and impact over the 10 years to become a global leader in the field, working with collaborators in a range of industries and disciplines. The research developed novel IP and in 2019/20 Mark and Rhush Maugi explored the market fit and opportunity. They launched a spinout company called "Figura Analytics" in 2021. Mark is now the CTO of the company and seconded into the company full time.

Figura Analytics aims to revolutionize the speed and accuracy of liquid analysis. The technology counts particles, of all shapes and sizes, to give you a 'fingerprint' of what your sample should look like. Launched in 2021 with £300k Innovate-UK funding, Figura Analytics secured >£900K of Venture Capital and Angel Investment. The beachhead market was the drinks industry, monitoring quality and microbiological contaminants. Working with Coca-Cola, Britvic, Tennents, St Austell Brewery and many others to validate the technology. In 2023 Figura launched its products and are growing sales in the UK and Europe, and more recently have been exploring the fit in medical, life sciences and pharmaceutical markets.



Surlender Pendress Co-founder, Love Writing Co. (2021 Pitch Up finalist)

Surlender Pendress is versatile entrepreneur of children's resources focused on the early learning resources and publishing sector.

As Co-founder of "Love Writing Co " Surlender seamlessly combines a passion for creating educational products with her e-commerce expertise. She has transformed her venture into a go-to platform for parents and educators seeking innovative writing tools.

Having the ability to understand the early learning sector needs and translate them into visually striking designs and innovative resources sets her apart.
